### Clerk / Treasurers Report

Working on the final warrants for fiscal year 2022

Working on fiscal year 2023 warrants.

Re-organizing the Clerk / Treasures office with a part time 20 hour a week daytime position. Have eliminated the part time evening position, but if the person would like to work per diem time can made available.

The hours worked by the assistant to the treasure has worked so far this in fiscal year 2023 will have a 4% per hour raise. The per diem amount will also reflect the 4% raise.

Two new firefighters have been brought on.

Question by Bruce what is the comparison of pay between Water Department and Clerk / Treasurers office, Terrie will have to look up correct numbers.

Question by Bruce what is the reasoning for the reorganization of the Clerk / Treasurer's Office – work load has increased and to have someone during the day helps with the work flow in the office.

Question from floor on new hire, was person terminated, answer no. The position changed from an evening position to a day position. The evening position could not work during the new day.

Discussion

Clerk / Treasurer will get info to answer questions on why workload for the office has increased

Question on how many applicants for the new part time position, there were 3-4 narrowed down to 2.

### Open Meeting Complaint

Deadline was missed by chair to respond, chair responded and sent the information to the state.

Towns and District work in different ways, Towns have restrictions and rules and regulations they must abide by. Towns need to post special meeting 14 days prior to the meeting, Districts need to post a special meeting 7 days prior to the meeting. Chapter 48 Section 66 of Fire Districts Fire Department states that a special meeting shall post 7 days in advance reinforced by Chapter 41 Section 166.
